Each vendor will receive two vendor wristbands.

Vendor wristbands must be worn all three days of the event. Any additional passes must be purchased at the venue gate at the regular gate price.

All Vendors must present a signed vendor agreement at check-in to collect vendor wristbands. No vendor vehicle will be allowed inside the venue during the event.

Vendors must be in compliance with city, state and local license and permit codes. It is the vendor's responsibility to obtain all appropriate licenses, permits and insurance at his/her own expense.

Vendors are responsible for paying their own sales tax as required by state tax laws.

KANSAS CITY, MISSOURI HEALTH DEPT REQUIREMENT & INSPECTION PROTOCAL

It is mandatory that vendors who are preparing, assembling, and/or serving food have obtained an application for a temporary food permit (this includes beverage vendors pouring drinks or adding ice to cups).

Vendors must be prepared, equipped and all requirements are met at least one hour prior to the start of the event to ensure start time of the event is not delayed.

It is recommended that all application forms and processing fees to be completed and submitted at least 14 days prior to the event. If submitted after the 14 days period permit fee will gradually increase.

Individual vendors are ultimately responsible for meeting all food safety requirements.

- Person- in-Charge present
- Demonstration of knowledge
- Proper hygienic practices
- No eating, drinking, smoking in food prep area
- No bare-hand contact w/ready-to-eat food
- Hand washing sink w/soap and paper towels
- Employees wearing clean outer garments
- Employees wearing hair restraints
- Consumption ice separated from coolant ice
- Utensils/Ice Scoops w/handles supplied
- Covered waste receptacle supplied
- Hot holding at 135F or above
- Steam Table
- Cold holding at 41F or below
- Outdoor Event: --Overhead Protection
- Sanitizer: chlorine
- Test strips provided for measuring concentration of sanitizer

- Sanitizer and other chemicals stored separately from food
- Flooring is smooth, durable, easily cleanable, and non-absorbent
- Grill has hinged lid or overhead protection w/screened sides

- Food and single-service items are stored at least 6" off the floor

## Port Improvement District #1 (PID1) FAQ

A. A PID is a district created by a port authority pursuant to Missouri Revised Statute 68.200-68.260 (Port KC in this case) for the purpose of collecting a 1% sales and use tax to be used for specific improvements and projects within the PID.

Q. What is the PID tax amount? A. The maximum tax that may be levied in a PID is 1%. The tax for PID 1 is a 1% sales and use tax. **Q. How do I report the PID tax?** 

**A.** The Missouri Department of Revenue is responsible for collecting the sales and use tax for PID 1. Vendors are responsible for reporting the sales and location of sales to the Missouri Department of Revenue. The address for Berkley Riverfront is 1298 Riverfront Rd., Kansas City, MO 64120.

**Q. What are the PID 1 boundaries? A.** PID 1 boundaries are illustrated on the map below. Berkley Riverfront Park is within PID 1.
